DREAM FOUNDATION'S DREAMS TOUCH LIVES, MEET ESSENTIAL NEEDS AND PROVIDE INSPIRATION, COMFORT AND CLOSURE AT THE END OF LIFE. IN 2023, THE AGENCY PROCESSED 583 REQUESTS FOR ASSISTANCE. IN 2024, THE ORGANIZATION PROJECTS 600 REFERRALS FROM OVER 150 HOSPICES THROUGHOUT THE UNITED STATES AND PUERTO RICO.
