DREAM FOUNDATION'S DREAMS TOUCH LIVES, MEET ESSENTIAL NEEDS AND PROVIDE INSPIRATION, COMFORT AND CLOSURE AT THE END OF LIFE. IN 2024, THE AGENCY PROCESSED 490 REQUESTS FOR ASSISTANCE. IN 2025 THE ORGANIZATION PROJECTS 550 REFERRALS FROM OVER 170 HOSPICES THROUGHTOUT THE UNITED STATES AND PUERTO RICO.
